2. Offer of appointment to the candidates empaneled will be issued by the respective allotted unit.
3. No individual queries in this regard will be entertained by RRC office.
4. The allotment of post and Unit shall be decided in due course and shall be subject to availability of vacancies, medical fitness, verification of certificates of Sports & educational qualification from the issuing authority, recognition of issuing authority for recruitment in Railways etc. and verification of candidate's credentials (character and antecedent) after following due procedure by the respective Divisions/Units. Offer of appointment shall be dispatched by respective unit.
5. Candidates may be posted against any vacancy/ post (in the recruited Level/ GP) in NCR, subject to candidate's fulfilling required educational qualification, medical fitness and training prescribed for that post.
6. Empaneled candidates will be under probation for a period of two years. Before completion of the probation period, the performance of the sportsperson shall be reviewed by the appropriate committee as mentioned in Railway Board's letter No-2010/E(sports)/4(1)/ (Policy) dated 31/12/2010.
7. If the performance of a sportsperson is considered to be unsatisfactory, the probation period will be extended maximum up to 02 years. Even after extended probation, if performance is found unsatisfactory, then normal procedure will be followed for termination before the completion of extended probation.
8. Empaneled candidates are required to furnish a Service Bond for Five Years as per Annexure – IV of Railway Board's letter No-2010/E(sports)/4(1)/ (Policy) dated 31/12/2010.
9. While due care has been taken in preparing the result, RRC/ NCR/ PRYJ, reserves the right to make amendment to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices are noticed or brought to the notice of RRC/ NCR/ PRYJ or administration at any stage, the RRC/ NCR/ PRYJ reserves the right to declare any candidate unsuitable and delete the name of the candidate from the notified panel. The decision of RRC/NCR/PRYJ in the matter shall be final.
10. This is only provisional panel and does not confer upon the candidates any right for appointment in Railway Service.
